Pi Browser is a block chain application of Pi.

Anyone who use Pi Browser to authorize Pi account name to log in PiPet platform can be registered automatically, then become to PiPet user. For more convenience, the User is referred to as "you" or any other applicable form of the second person pronoun.

## 三、注册

### Registration

## 四、服务

## Service

本网站仅为您通过本网站从事商品或服务、资产交易活动（包括但不限于数字资产交易等）提供在线交易平台服务。本网站不作为买方或卖方参与商品或服务、资产交易；本网站不提供任何国家法定货币的充值和提现服务。

PiPet website only provides online trading platform services for you to engage in goods ,services, or asset trading activities (including but not limited to digital asset trading, etc.).

PiPet platform does not participate in the transaction of goods, services or assets as a buyer or seller; PiPet platform does not provide recharge and withdrawal services of any national fiat currency.

### 4.1 服务内容：

#### 4.1 Service content:

4.1.1 您有权在本网站浏览商品或服务、资产的实时报价和交易信息，有权通过本网站发布和购买商品或服务、资产。

4.1.1 You have the right to browse real-time quotations and transaction information of goods or services and assets on PiPet website, and have the right to publish and purchase goods or services and assets through PiPet website.

4.1.2 您有权查看本网站用户账户下的信息，并有权使用本网站提供的功能。

4.1.2 You have the right to view the information under the user account of PiPet platform and have the right to use the functions provided by PiPet

4.1.3 您有权按照本网站发布的活动规则参与本网站组织的网站活动。

4.1.3 You have the right to participate in PiPet activities organized by PiPet platform in accordance with the activity rules published on PiPet platform.

4.1.4 本网站承诺为您提供的其他服务。

4.1.4 PiPet promises that Other services will be provided to you.

### 4.2 服务规则 您承诺遵守本网站的以下服务规则：

#### 4.2 Service Rules : You undertake to abide by the following service rules of PiPet platform:

#### 4.3 Rules for the purchase of goods or services and assets

4.3.1 You undertake that you will properly abide by the following transaction rules during the process of logging in to PiPet platform and conducting transactions with other users through PiPet platform

4.3.2 Browsing transaction information, when you browse transaction information on PiPet platform, you should read all the contents in the transaction information carefully, including but not limited to physical or virtual items, price, inventory, freight, place of origin, transaction time limit etc. , after you confirm accept everything contained in the transaction information, you can click the button for trading.

4.3.4 The view of transaction details, you can view the corresponding transaction records in the transaction report through the balance to confirm your detailed transaction records.

4.3.5 联系卖家，您可以通过本网站提供的与卖家沟通渠道与卖家进行联系，在本网站以外联系卖家造成的风险及自身损失，您应自行承担，与本平台无关。

4.3.5 The contact to the seller, you can contact the seller through the communication channel with the seller provided by PiPet platform. You should bear the risks and losses caused by contacting the seller off the PiPet platform and those kind of lost have nothing to do with PiPet

4.3.6 查收商品或服务、资产，当交易被卖家取消时，您支付的 PI 会自动退还至您在本网站的账户余额中，当您确认商品或服务、资产交易无误后，您可以点击确认收货按钮，确认收货以后，您可以对该交易进行评价，不可退货或退款，您的该笔交易信息将会永久记录在区块链中。当您认为商品或服务、资产不符合您的要求时，您可以通过本平台提供的与卖家沟通渠道和卖家进行沟通协商，进行退换等售后服务。

4.3.6 The receive of the goods, services or assets.

When the transaction is canceled by the seller, the PI you paid will be automatically refunded to your account balance on PiPet platform. After you confirm the goods, services or assets are correct, you can click the "Confirm Receipt" button, after confirming receipt, you can comment on the transaction, but cannot return the goods or refund, and your transaction information will be permanently recorded in the block chain. When you think that the goods, services and assets do not meet your requirements, you can communicate and negotiate with the sellers through the communication channels provided by PiPet platform to carry out after-sales services such as returns and exchanges.



4.3.7 申请平台介入，当您与卖家进行商品或服务、资产交易时，发现卖家可能存在欺诈行为或已经发生欺诈情况，您可以申请平台介入，举报或申请平台仲裁您的该笔交易。平台将本着仲裁规则对您提交的凭证进行核查，依照仲裁规则，客观、公平地进行仲裁。

#### 4.3.7 Apply for platform intervention.

When you trade goods, services, or assets with the seller and find that the seller may be fraudulent or has already committed fraud, you can apply for the platform to intervene, report or apply for the platform to arbitrate your transaction. The platform will check the vouchers submitted by you in accordance with the arbitration rules, and conduct the arbitration objectively and fairly in accordance with the arbitration rules.
